## BCPE Endorsed by International Ergonomics Association

BCPE is now endorsed by the International Ergonomics Association (IEA) as an accredited ergonomics certifying body. IEA President Waldemar Karwowski made the announcement at the BCPE Networking Reception during the HFES Annual Meeting in Minneapolis. As the first certifying body in the world to gain such recognition, this is a great honor and distinction for the BCPE.

IEA developed the accreditation program to further its goal to establish professional practice standards for ergonomists around the world. Shortly after the announcement, IEA Past President Ian Noy said, "the (accreditation) program is key to achieving the principal objectives of the IEA, including the development of the discipline and the promotion of ergonomics."

The IEA endorsement is a strong testament to the quality of the BCPE certification program. It will enhance respect for the certification program and increase recognition for those holding BCPE certification.

### The Application

The accreditation application was completed during the early summer of 2001. Most of the effort was shouldered by the capable BCPE staff -- Kris Alvord, Executive Administrator, and Karel Jahns, Financial/Information Systems Manager. Ms. Alvord and Ms. Jahns worked many hours over several weeks compiling the necessary information. In addition, there were major contributions from Directors, Andy Imada and Bob Smillie. The application process was extremely rigorous and required extensive documentation of BCPE's policies and procedures. Some of the sections in the application were:

- Complete financial statements for the past 3 years.
- The history of BCPE.
- The countries and the numbers of BCPE certified individuals (BCPE currently has certificate holders in 14 countries.)
- A tally of applications processed and certifications awarded by year.
- Agreements with other organizations.
- Requirements for certification.
- The BCPE processes for applications, evaluations, and appeals.
- The process for examination development and administration.
- The process for certification maintenance.

### IEA Review

Once completed, the application package was sent to the IEA for review by: Dr. Carol Slappendel of New Zealand, Ms. Elizabeth Bunker of Australia, and Dr. Francois Daniellou of France. After an initial evaluation of the application, some additional information was requested. When all requisite information had been provided and after a reasonable time interval, the review group approved the BCPE application and recommended to the IEA Executive Committee that BCPE be accredited as an ergonomics certifying organization.

Congratulations to the BCPE staff for such an outstanding effort, and thanks to all the certificate holders for ensuring BCPE continues to be a world class organization!

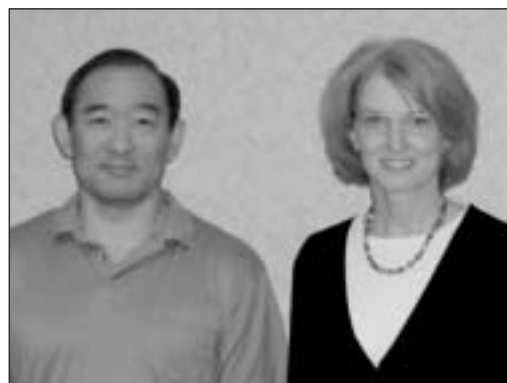
### Susan M. Evans, PhD, CPE

Dr. Evans is President of Evans Incorporated, a management consulting firm that provides process innovation, information technology planning, and ergonomic program management services. She manages teams of certified professional ergonomists and experienced business analysts, information analysts, industrial engineers, and usability specialists in projects that overcome workplace ergonomics health problems,

Dr. Evans brings over 25 years of management and design experience in ergonomic systems, process innovation, and information technology. She led user-centered design efforts for government and commercial systems, and worked with corporate health, safety and ergonomics (HSE) managers to develop effective hazard assessment practices and supporting HSE risk management systems. She has applied web technology to effectively track and share ergonomic concern reports with workers, engineers, and managers throughout global client companies. Prior to founding Evans Incorporated, she developed human modeling and ergonomic design tools for use in cockpit and industrial design, conducted manpower, personnel and training studies, and led process reengineering and system design efforts for clients in manufacturing and the US Army, Air Force, and Department of Defense.

### William H. Muto, PhD, CPE

Bill Muto is a principal (human factors) engineer at Abbott Laboratories, where he performs human factors engineering on a variety of health care devices such as hospital laboratory diagnostic systems, patient monitoring systems, various bedside and hand held devices. (Bill thinks this work most gratifying in that the perceived need for safe, "human factored" devices is high—especially when one thinks that he/she could be a patient.) Prior to his current position, Bill held various management and senior engineering positions at Texas Instruments and Xerox Corporation where he worked in a wide variety of application domains including office automation systems, factory automation systems, consumer products, artificial intelligence, workstations, etc. Bill holds a Ph.D. in industrial engineering / human factors from Virginia Tech and a M.A. in human factors psychology from CSU, Northridge. He serves on Association for the Advancement of Medical Instrumentation (AAMI) human factors standards committee and is an associate editor of *Ergonomics in Design* magazine. He is also a principal in Human Factors Plus, a human factors consulting firm.

## Randolph G. Bias, PhD, CHFP

Since getting a Ph.D. in human experimental psychology from UT-Austin, Randolph has worked in industry for over 20 years as a usability engineer. After stints with Bell Labs, IBM, Tivoli, and BMC Software (where he created and managed the Usability Department), Randolph co-founded Austin Usability, an independent usability lab and consultancy. Randolph has published over 50 technical and scientific articles, and co-edited *Cost-Justifying Usability* (R. G. Bias and D. J. Mayhew, Eds., 1994, Cambridge: Academic Press), a book characterized by one reviewer as "the bible for usability engineers." He is a Certified Human Factors Professional, and is active in professional societies such as the Human Factors and Ergonomics Society and the Usability Professionals Society. Randolph is an adjunct faculty member in the UT Graduate School of Library and



Information Sciences, and has taught undergraduate and graduate courses in psychology and statistics at UT, Rutgers University, Huston-Tillotson College, and Southwest Texas State University, plus has taught many short courses for industry. He is a vigorous advocate for designing technology to fit the user.

# Highlights of BCPE Annual Business Meeting

BCPE held its Annual Business Meeting on October 11-13 in Minneapolis, MN during the Human Factors and Ergonomics Society (HFES) meeting. Highlights of the meeting include:

Arnie Lund, chair of the Web Site Committee, indicated that content for the site redesign was coming together and plans for user testing are in place. It is anticipated the newly designed site will go public in mid-January.

Kris Alvord reported for the Marketing Committee that the PowerPoint presentation developed by Anna Wichansky and Jayne Schurick has been completed and is on the present web site for viewing and download.

Steve Johnson, chair of the Recertification Committee, reported that the committee was recently expanded to include several non-board members. The committee has plans to meet electronically throughout the year to continue discussion of recertification.

Treasurer Andy Imada spoke about the budget and pointed out that a shortfall at the end of the year may be likely. Although a small reserve might be enough, strategies to resolve this temporary cash flow problem were discussed further in a breakout session.

Expanding the pool of application evaluators is in progress. Certificate holder Dick Kelly has agreed to head a committee to oversee the evaluation process and other certificate holders will be recruited to assist with the evaluation process. Work is also progressing on developing a pre-screening process for applicants who are unsure of their eligibility for BCPE certification. As part of the application evaluation committee, Dick Kelly will facilitate the development of a feasible process.

Exam development and administration issues were discussed. A number of matters had been identified as needing to be addressed. It is now a matter of prioritizing those matters and formulating a strategy of how to proceed.

A strategic planning session was led by Director Emeritus, Jerry Duncan. A summary of the session follows:

- 1) The mission statement was revised. It is: *Provide ergonomics certification to protect the public, the profession, and its professionals by assuring standards of competency and advocating the value of certification.*
- 2) The vision statement was revised. It is: *Provide premier certification recognized as essential for ergonomics practice.*
- 3) The updated "BCPE Yearbook" was reviewed.

Progress was reported on moving the newsletter from a paper to an electronic publication. The first electronic edition was forwarded in August, although it was later learned that due to problems with the mail server, the newsletter was not received by the intended recipients. The problem was resolved, and the newsletter was resent.

Director Emeritus, Steve Casey, has agreed to document BCPE's early years.

The process for appealing an application evaluation or an examination outcome was revised. It was further amended to limit the time allowed to file an appeal to one year.

Officer elections were held. The current slate of officers

was re-elected unanimously: President, Bob Smillie; Vice President, Dave Alexander, Treasurer, Andy Imada; and Secretary, Gary Orr.

Discussion of the Usability Professionals' Association implementing its own usability certification ensued. It was felt we should talk with UPA to explore the possibility of offering a specialty exam in HCI. Arnie offered to do this as he has been invited to participate in the initial round table discussions.

Tentative dates for the midyear meeting were set as April 26 Friday noon thru all day Saturday April 27 or alternatively May 3 and 4.

## Call for Contributions

Contributors are sought for a comprehensive reference text in the forensic application of human factors, ergonomics and safety. *The Handbook of Forensic Human Factors and Ergonomics* is scheduled for publication by Taylor & Francis, Ltd. in 2003. This handbook will address the role and application of the science of human-system interactions to matters concerning standard of care in the design and use of products, equipment, premises, and work systems.

The scope covers a broad range of forensic applications including general testimony issues, standards, warnings, consumer products, industrial machinery, manufacturing, legal issues in work-related musculoskeletal disorders, toxic hazards, construction safety, slips and falls, disability, ADA and human factors, transportation, public utilities and facilities, traffic collisions, process liability, professional ethics, malpractice issues, sports and leisure activities.

Authors must be able to relate human factors and ergonomics theory and methods to forensic practice. # The IEA-Liberty Mutual Prize in Occupational Safety and Ergonomics

## The IEA is inviting applications for the 2002 Liberty Mutual Prize

*(Please note, the submission deadline is March 1, 2002)*

Through this prestigious award, the IEA seeks to recognize outstanding original research leading to the reduction or mitigation of work-related injuries. The main criteria include significant advancement of theory and understanding, innovation and development of new directions or approaches.

The award recipient will receive a prize of \$5,000. In addition, the award recipient will be automatically competing for the 2003 Liberty Mutual Medal. The Medal, carrying an additional stipend of \$15,000, will be awarded during the IEA Triennial Congress (Seoul, Korea) to the best of the 2001, 2002 and 2003 Prizewinners.

Applicants need not belong to the IEA or any of its constituent groups. Relevant disciplines include ergonomics, epidemiology, biomechanics, cognitive and behavioral psychology, design, physiology, medical sciences, economics, engineering, etc.

### Submission Requirements

To be considered for the Liberty Mutual Prize, the applicant must submit a letter of application and a research paper in the domain of accident prevention, injury reduction and/or early return to work, including rehabilitation. The paper must:

- be scholarly in nature such as an original paper describing laboratory, field, or intervention research .
- contain non-proprietary data
- be unpublished at the time of submission (but may have been submitted for publication)
- be thirty pages or less, single-spaced using point size 12 with 1 inch margins

## Opportunities to Volunteer for BCPE

The BCPE continues to grow and seeks your support as a volunteer on one of BCPE's various standing committees or with other certification-related activities. The momentum for our success comes from the leadership of individuals like you, who are willing to contribute your knowledge, skills, and expertise to help BCPE achieve its goals and to further its mission. While we have critical needs in the Application Committee (streamlining the application evaluation process; developing pre-screening procedures) and the Examination Committee (revision of examinations; development of examination questions), we are always in need of proctors for the examinations, contributors of original articles for *The Professional Ergonomist*, as well as help in other areas.

The paper should address the following topics:

- contributions of the research to theory, i.e., how the work had advanced the understanding of the causes of accidents and/or ability to mitigate occupational injuries or disability
- aims of research
- originality and creativity
- study methodology
- implications for risk reduction

The cover letter should highlight:

- main innovative aspects of the study (e.g., approach, methodology, analysis, etc.)
- anticipated contribution to occupational safety

An international review committee established by the IEA will select the winning contribution

The authors of the winning paper are expected to submit the paper to *Ergonomics* for publication. The authors may make a case to have the paper submitted to an alternative journal for publication.
