# **President's Message**

Greetings fellow certificants, and happy holidays! I wanted to provide a brief summary of the board's actions since the last newsletter.

First, we experienced a bittersweet farewell to Gene Kay and Cynthia Rando, both highly committed and dedicated board members who have concluded their terms as directors. I had the pleasure of working with both since I joined the board in 2019 and will miss the experience and wisdom they brought to every board discussion.

At the annual meeting in Phoenix, AZ, the board spent a considerable amount of time focused on concluding a multi-year analysis of our certification process. In that analysis, we identified areas where the process can better serve professionals as well as the customers and employers who seek individuals with skills in human factors and ergonomics. Practitioners in our field must bring "T shaped skills" that include a broad but shallow awareness of the whole field coupled with depth and expertise in one or more areas. Our current exam attempts to assess both the breadth and depth components at once, which is not ideal.

The board adopted a motion to modify the certification process to better reflect the journey that practitioners take. Many start that journey in an academic environment where they begin accumulating the broad knowledge of the field. Later, work on projects allows for focused work in

one or more specialized areas. These precursors set the stage for developing the necessary knowledge and skills that define a competent professional and using the CPE/CHFP designation. The changes to our certification model will enhance evaluation of the specialized knowledge that focuses on domain specializations that align with domains identified by IEA that include *physical, cognitive,* and *organizational* ergonomics. Finally, we recognize there is often a gap in knowledge and skills between newly certified professionals and those with significant additional experience beyond our current assessment of competence. Thus, we are defining the criteria for a level of highest recognition defined by outstanding achievements and accomplishments as a practicing professional. There is much more information to come as the specifics of this model are enacted and the board and staff are working diligently to employ this new model.


Volunteerism forms the pillar upon which these activities occur, and we welcome your assistance in realizing these plans. I thank all who already have and continue to volunteer – we received a terrific response for a call for question writers, and we look forward to receiving your inputs by late January. Conferences benefit from the time folks donate to help make others aware of what BCPE offers. Finally, for those looking to work more directly on the board I encourage you to submit an application in the late Spring as we seek to fill two positions that will be open starting the Fall of 2025.

We thank our certificants for their continued dedication to this valuable field and BCPE looks forward to continuing to advocate for rigorous professional standards in a world with ever changing and complex systems with which we humans must interact.

# **Annual Meeting Highlights**

The BCPE Board of Directors held their 2024 Annual Meeting in Phoenix, AZ on September 13 and 14 at the end of the HFES Aspire Conference. The following summarizes meeting reports and activities.

- Year to date (9/13/24) a total of 91 applications have been received: 29 Professional, 50
  Associate and 12 transition applications. It's anticipated these numbers will increase with
  the upcoming November application deadline.
- We continue to do a good job forecasting and managing our expenses. It's anticipated our yearly expenditures will remain within budgeted projections.
- Website and Operations reports forward progress in our transition to a new database and web site relaunch. These changes will provide us with more control over our data at significant savings.
- Outreach and Communications summarized accomplishments since the last annual meeting. This includes rebranding the outreach slides, updating exhibit materials and relaunching the <u>BCPE Store</u> with new merchandise. Social media metrics, trends and goals were also discussed.
- The Certification Committee outlined planned activities for the upcoming year to include a call for new questions and drafting and reviewing new competencies.
- A new conceptual certification model was adopted.

#### **MAGGIE MA**



Dr. Maggie Ma is a board-Certified Human Factors Professional (CHFP) and a Technical Fellow in Human Factors Engineering at The Boeing Company. She has substantial experience in developing various safety programs (e.g., reactive, proactive, and predictive) through working closely with airlines, manufacturers, maintenance organizations, ground service providers, regulatory agencies around the world. Maggie is an enthusiastic technical leader with a clear vision and a track record of successfully applying human factors knowledge and skills to improve aviation safety. In recent years, she has been focusing on

transforming aircraft maintenance operations and Boeing commercial customer support operations through innovations using Mixed Reality technologies.

Maggie received her Ph.D. in Industrial Engineering/Human Factors Engineering in 2005 from State University of New York at Buffalo.

Maggie and her former lead, Dr. Bill Rankin received the Engineering Team of the Year Award for Boeing Commercial Aviation Services in February 2013. Maggie received the Boeing Service Culture Excellence Award in June 2018. Dr. Ma was selected as a Fellow by the Royal Aeronautical Society in 2023. In July 2023, she was featured in a Boeing Voices of Safety video.

#### **THOMAS ROWELL**

Tom is a Certified Professional Ergonomist with 35 years of industrial experience.

He started in ergonomics at IBM in Austin, TX where he was responsible for ergonomics program development and implementation for the site of over 10,000 employees (15 buildings, 235 acres, and 2.1 million square-feet of building space). He has years of experience with workplace evaluation and analysis, injury investigation, design review, equipment inspection,



ergonomics and safety auditing, medical staff interface to reduce injury severity and worker's compensation costs, and ergonomics training. He spent seven years as manufacturing operations manager for an OEM company that makes sanitary filters for the food and beverage industry.

He is a member of the Human Factors & Ergonomics Society and the Applied Ergonomics Society (IISE). He holds a master's degree in Industrial Engineering from Texas A&M.

Since 2014 he has been a consulting ergonomist in his own practice providing services to small, medium, and large clients throughout the United States.

From 2020 to present Tom has been involved with planning of the annual IISE/Applied Ergonomics Conference (2024 & 2025 Keynote committee co-chair). In 2021 Tom was tapped to become liaison between HFES and AES to help facilitate and grow the connection between the societies resulting from the society's MOU. In 2022 Tom was elected to a position within HFES in the Occupational Ergonomics Technical Group (HFES Aspire: 2024 OETG Program Chair).

## **FPE Student Award Submission Deadline**

The Foundation for Professional Ergonomics has announced the 2025 deadline for the Dieter W. Jahns Student Practitioner Award. The award was created in memory of Dieter Jahns, a lifelong advocate of the practice of ergonomics and a leader in ergonomics certification. The submission deadline for the 2025 award is April 15, 2025. Notification of the winner will be sent by May 31, 2025.

The annual award is given to the student (or group of students) for a project that demonstrates the major practice areas of ergonomics: Analysis, Design, and Integration. The purpose of the award is to advance professionalism in ergonomics by recognizing educational activities that demonstrate how professional ergonomists serve to make people's lives at work and at home healthier, safer, more productive, and more satisfying. The award is open to all students in

ergonomics and ergonomics-related programs. Students who have completed their graduate degrees within one year of submitting are also eligible. The award and cash prize of \$1,000 will be presented at the BCPE/FPE/HFES Joint Reception, during the HFES Aspire Conference, October 12-17, 2025 in Chicago, IL.
